# Message from the Chairman

**It** is my pleasure to report to you on the challenges and progress of this organization for the period July 2011 to June 2012.

One of our main challenges for the last fiscal year was the loss of staff. Sadly our Education Officer Erica Daniel decided to return to elementary education and left us in August to join the teaching staff at a local Primary School.

Unfortunately, we have not been able to replace her and although certain aspects of our education programme have been put on hold, school visits and field trips have continued to be conducted by other staff members.

Both our General Manager, Frank Balderamos, and our Marketing and Development Officer, Erika Walton, left the Trust to pursue their careers in the private sector. Although it took some time, we were delighted to welcome our new General Manager, Christina McTaggart, and our new Marketing and Development Officer, Basia McGuire, to our team in January 2012. I am happy to say that in six short months much progress has been made and the team is working well together.

Another challenge was, and continues to be, funding. Our general fundraising events were well attended, but did not meet the budgeted return, and there was a further cut in our annual Government grant. As a result, we were forced to make cuts in several areas. In addition to not filling the position of Education Officer, the Mission House coordinator is now a part-time position, and the Cayman Wildlife Rescue programme was suspended in October 2011.

Nevertheless, despite these challenges, we have continued to fulfill our mission and have made significant progress in many areas and I ask that you take the time to read the reports of each programme as I will only be mentioning some of the highlights.

Our Historic Programmes Manager, Denise Bodden, spent several months based at the Mission House and during that time, significant repairs and painting were carried out. We were glad to have her return to the main office in March and, since then, highlights of the programme have included the celebration of the Fifth Anniversary of the Mission House and the completion of a significant renovation of Guard House Park.

In February 2012, we were very pleased to promote Paul Watler to the position of Environmental Programmes Manager. This position had been vacant for



several years and we are very excited to have it filled by a young Caymanian with excellent qualifications. You will see from his report that he and our Field Officer, Stuart Mailer, have been very busy. Highlights of the environmental programme include attending various workshops overseas, and successful applications for several grants (both local and international).

Two very significant land acquisitions in Grand Cayman were made over the past fiscal year. A parcel of 118 acres located in the middle of the Mastic Reserve was purchased, as were 23 acres in the Salina Reserve. We were also very grateful to Mrs. Brigitte Kassa for funding the purchase of a two-acre parcel in Little Cayman, adding to our holdings on the Salt Rocks Nature Trail.

The Blue Iguana Recovery Programme has continued with the business of restoring blue iguanas to the wild, along with other aspects of the programme, including the planning of a trail system in the new Colliers Wilderness Reserve which, thanks to the newly completed road, is now easier to access.

New this year is the creation of a Sister Islands Rock Iguana Species Recovery Plan. Recognizing the need to ensure the population of these special creatures continues to prosper, a stakeholders' meeting was held in August 2011. Attendees included representatives from Durrell Wildlife Conservation Trust, the International Reptile Conservation Foundation, the Department of Environment, and the Trust, as well as volunteers from Cayman Brac and Little Cayman. Since then, a count has been conducted in Cayman Brac, and the Trust, through our Land Reserve Fund (and the Little Cayman District Committee), has been fundraising to purchase the largest communal nesting site in Little Cayman. Thanks to the International Reptile Conservation Fund, US citizens were able to make tax deductible donations, and as at

30<sup>th</sup> June 2012, over US\$100,000 had been received in this manner.

Throughout the year we get a number of volunteers who help in so many different ways. Some are volunteer groups from local firms, some are individuals who help on a regular basis throughout the year and some help us on an ad hoc basis. It is particularly gratifying when a high school student enquires as to how they can help.

In July 2011, with the assistance of two young volunteers, we held a two-week long summer camp, while another young volunteer went through the arduous task of updating our Facebook page and our scrapbook of newspaper articles. This year again we have had the pleasure of being assisted by a young college student who has done various tasks from checking our new website for errors to assisting with the Parrot nesting count in Cayman Brac.

Thanks also to an excellent team of volunteers, a very successful History Week was hosted at the Mission House in November 2011. The Year 7 students at Clifton Hunter High School were treated for three days to a series of lessons including baking a traditional cassava cake, making a coconut boat, as well as learning the history of the Goldfield, Cimboco and Lady Slater schooners after which their academies are named.

In honour of our 25<sup>th</sup> Anniversary, we are pleased to announce the launch of our 10 x 20 Challenge as part of our Conserve Cayman campaign. Whilst I am pleased to say that as at June 2012 our total land holdings stand at 3,133 acres, this represents a mere 5% of our land mass whilst the internationally recognized standard is 15%. The 10 x 20 Challenge aims to conserve 10% of our islands' land mass by 2020. Whilst it may seem a tall order, simply put, we cannot take another 25 years to attain this goal.

In addition, the historic work of the Trust must continue, and you can look for renovation work to begin at Fort George as well as at the Eldemire House in Cayman Brac.

In the next fiscal year the Trust will face additional challenges as Government funding is cut further, and as the pool of available resources continues to shrink in these tough economic times, but we will continue to fulfill our mandate to the best of our ability. We thank our members, private and corporate donors and the general public for their continued support and ask you all to attend our events, volunteer whenever possible, and urge friends and family to join the Trust and help us conserve Cayman.

Lastly, I must thank our small but dedicated staff for their tireless work as well as our faithful volunteers who show up every week. Your help is sincerely appreciated.

I would also like to thank our council members for another year of sitting through long meetings and making some tough decisions. Thanks to those who will continue to serve as well as outgoing council members Bing Thompson and Sonya Carlesso, and a warm welcome to our new council members.

# General Manager's Report

*Christina McTaggart, General Manager*



The GM started 2012 with a running leap into the deep end of her dream job. Nine months later she is still very much enjoying the daily challenges and occasional victories that make not-for-profit work so exciting.

## **Fundraising and Awareness**

During her interview for the post of General Manager, Christina was asked what she thought were the two most important issues facing NGOs to which she quickly responded "Awareness and Funding". The interview panel seemed quite pleased with her answer and she quietly patted herself on the back. Over the past nine months the new GM has become personally acquainted with just how challenging those two issues are for a charity.

It was in fact these twin challenges which prompted a plan to secure the financial sustainability of the Trust as it has become blatantly obvious that the Trust can no longer rely solely on dwindling government subventions or sporadic corporate donations.

Thus, in an effort to secure more sustainable streams of income, the Conserve Cayman campaign was devised to secure multi-year partnerships with corporate sponsors, donors and other civil society organisations. Christina, Basia and the Chairman have given numerous fundraising presentations, which clearly outline the mission of the Conserve Cayman campaign, to potential corporate sponsors and foundations since January 2012.

Christina was invited to address the Cayman Islands Youth Parliament in relation to their debates on the Environment and had an opportunity to share the vital work of the Trust with a tenacious group of young student leaders.

Christina and Basia attended many outreach events including several Musician and Arts showcases at Camana Bay, Earth Day festival also at Camana Bay, Rotary Club of Grand Cayman guest speakers, Daybreak television appearances and various

radio appearances.

A quarterly lecture series which had not been active for awhile was revived when the Trust hosted a lecture on Important Bird Areas in Cuba by Dr. Arturo Kirkconnell towards the end of the financial year. Working along with Dr. Rosenthal of St. Matthews University the Trust now has several guest lecturers lined up for the next two quarters.

## **Operations and Administration**

Internally, a number of improvements have been made during the last 9 months at the Trust which have increased the effectiveness and efficiency of Trust operations. Such improvements include the remodelling of the physical office, launch of a new Trust website which boasts online membership registration capabilities, online event registration, new server and network infrastructure and a modern member management software programme which helps the Trust to manage members, volunteers and donors more professionally.

## **Networking and Development**

The GM and the Chairman were invited to attend a working group in British Virgin Islands by CANARI where they had the opportunity to network with other conservationists from the Caribbean region including the Turks and Caicos National Trust, Anguilla National Trust, Montserrat National Trust, British Virgin Islands National Parks Trust and the international arm of the UK Royal Society for the Protection of Birds.

The Trust also hosted a week long project steering committee meeting for an EU sponsored Management of Protected Areas to Support Sustainable Economies (MPASSE) project in early June for attendees from Turks and Caicos National Trust, British Virgin Islands National Parks Trust and the UK Overseas Territories Conservation Forum. The delegates had an opportunity to visit the site of the Blue Iguana Recovery Programme's future facility, amongst other things.

## **Programmes Support**

With respect to the Education programme, the



GM was awarded a small grant from the Caribbean Natural Resources Institute (CANARI) to establish an after school club that she developed called “Guardians of the Environment”. This club was designed to help bridge the gap in the Education programme in the absence of an Education Officer.

In regards to the Historic Programme, the GM along with the HPC Chairman met with one of the donors of the Eldemire House site in Cayman Brac in order to discuss possibilities as to the use of the house once the Trust had repaired the structure. The GM also assisted the Historic Programmes Manager with the planning and execution of Historic Programme events such as the Mission House’s 5th year anniversary celebration. The GM has been involved in the ongoing planning for the Fort George improvements along with the Historic Programmes Committee.

Regarding the Environmental Programme, a number of volunteers were secured to assist the Environmental Programmes Manager with the Brac Parrot nesting survey for an ongoing period since April 2012 to present. The Trust would like to express gratitude to the following volunteers: Stuart Mailer, Basia McGuire, Fred Burton, Tomas Allen, Doug Bell, Tayvanis Oyog, Thomas Sevik and Sara Gregson.

## Conclusion

Although the GM has not had the benefit of being at the Trust for the entire financial year, much has been accomplished in the relatively short time since her arrival. She applauds her dedicated staff for being made of the right “stuff” that it takes to make an important organisation like the Trust thrive and is proud to be working alongside each of them.

# Historic Programmes Report

## Fort George

A presentation by the HPM to Walkers during the summer outlined the needs and desired improvements at this important 1700's historic site, which include boundary protection, a mural, elevation of the "Lookout" and improved landscaping. We are delighted to report that Walkers Foundation very generously donated C\$50,000 toward the project. John Broad has been chosen to paint the mural to depict scenes from the WW II era, and the late 1700's when Spaniards from Cuba attacked Grand Cayman.

## Watler Cemetery

Cathy Frazier donated C\$500 toward the maintenance of the site.

## Eldemire House

A site visit to the Brac was conducted by the HPC Chair, Sonya Carlesso and General Manager, Christina McTaggart in early 2012. Due to the economic downturn and the urgent needs of the structure, the decision was made to restore the house as a residence. This will ensure expediency and minimize further damage by the elements. The restoration and repairs will be done to allow for flexibility in future use.

The boundary survey was completed with Government assistance and shows that the property is somewhat smaller on the east side than originally thought. Negotiations with the adjacent property owner to expand our property were unsuccessful. While this was unfortunate, it is manageable. We have requested an estimate revision on site work and a quantity surveyor has agreed to carry out a review of the costing, to ensure the Trust receives good value for its limited funds.

## Mission House

The Mission House Coordinator, Aida D'Angelo, left in August 2011 and was replaced in March 2012 by Jennifer King. As a result, Mission House was closed during the month of September and the HPM spent October to mid-March providing tours, overseeing repairs and gardening, as well as training Mrs. King.

Mission House and the Visitor Center were entirely repainted in October and November by Boosie Arch Builders. However, due to funding restrictions, we are now looking for volunteers to assist with the repainting of the restroom, cistern and picket fence, as well as help with heavy-duty gardening around the boundary.

## Guard House Park

A C\$17,000 donation from the Department of Tourism has enabled much needed repair work and landscaping to this historic site and information center. The roof on the information center was re-thatched by Richard Bodden, the site landscaped by East End Garden and Gifts, Boosie Arch rebuilt cannon carriages, and Vision Marketing created new signage for the site. Picnic benches were acquired from Wood-Works. The site, reopened on June 29<sup>th</sup>, is now a more

attractive and educational stop for the public to enjoy.

### **General Maintenance**

Historic properties were maintained and cared for throughout the year as funds allowed. Due to a shortfall in funding, only four of our twelve historic sites are maintained.

### **Activities:**

Spooky Traditions – cancelled the day of the event due to flooding. Thanks to all the volunteers who were willing to assist with this much-anticipated event.

Christmas Bus Tours – tour points of interest included Mission House, private yards, and other festively lit areas along the way. Traditional Christmas fare provided from the kitchen of Joan Barnes. Thanks to volunteers for assisting with the tours and leading the caroling!

Slide Presentations/Cooking Classes & MH Dinner – due to staffing constraints these events all had to be postponed until additional staff or volunteers can be found.

### **Events and Collaborative efforts at Mission House:**

History Week – the second annual co-production between the Education and Historic programmes saw the HPM assisting with the planning stage and conducting tours during the week.

Special thanks to volunteers and food and beverage donors. Activities included a slide presentation on the Cayman-built Cimboco, Lady Slater and Goldfield schooners, tours of the house and grounds, a cooking demonstration, a catboat talk, and toy-making.

Gimistory - this CNCF production was held here for the second consecutive year and was well attended.

Christmas Lighting and Tree Contest – another co-production between Historic and Education programmes with the HPM coordinating lighting and decorating and emcee duties. Special thanks to all the volunteers and Education staff who arranged for school participation and donations of food and drink.

5<sup>th</sup> Anniversary Celebrations - were held at MH on the morning of Saturday, 23 June drawing a small and appreciative crowd. The 4<sup>th</sup> anniversary celebrations were

actually held in this fiscal year as well, in late summer 2011. The unveiling of a mural by Mrs. Joyce Everhart-Hoff dedicated to the children of Cayman with many iconic images of yesteryear marked this year's event. The HPM worked with Museum curator, Debra Barnes-Tabora, to create a new exhibit on our island's built heritage, specifically local wattle and daub construction.

Thank you to Jennifer Hunter for donating an antique china tea set and Janilee Clifford for an antique basin and ewer.

Ongoing activities - The HPM continues to assist in public and private school education due to the shortage of Education Programme staff at the Trust, as well as responding to questions from the public and providing assistance to local and international media.

If anyone has been shy in coming forward to assist the Historic Programmes, now is the time to break your reserve and boldly step up to the plate! Our Islands'

built heritage is vital to our tourism product, in creating an authentic ambiance and telling our story to both our children and our visitors.

# Environmental Programmes

*Paul Watler, Environmental Programmes Manager*



The Environmental Programmes Manager has had a very busy and rewarding year.

## **Training and development**

In July 2011, with kind support from the Governor's Office, Paul

was able to attend the regional conference Society for the Conservation and Study of Caribbean Birds, held in the Bahamas. The theme of the meeting was *"Connecting with Nature through Birds."*

Sessions and workshops focused on methods to engage a larger and more diverse audience by inspiring interest in nature. While there, Paul had the opportunity to meet many other conservation professionals from across the Caribbean, and was able to keep abreast of various environmental initiatives being carried out elsewhere.

In April 2012, Paul was fortunate to be chosen for the Caribbean Emerging Wildlife Conservation Leaders programme, and attended a week-long session in Antigua. The programme is funded in part by the U.S. Fish and Wildlife Service and supported by the International Fund for Animal Welfare and aims to provide up-and-coming conservation professionals in the Caribbean with the opportunity to work and learn from proven conservation leaders.

Paul had the opportunity to learn from a variety of experts at the pinnacle of their careers and to interact with young conservationists and environmentalists who work in the Caribbean region. Three training sessions are planned over a two-year period and Paul looks forward to the continuation of the program.

In June 2012, again with funding from the Governor's Office, Paul attended a workshop on seabirds hosted by the Society for Conservation and Study of Caribbean Birds, again held in the Bahamas. The workshop taught field identification, honed

survey planning and execution, and further developed data analysis and grant-writing skills. Some excellent contacts were made in the conservation community, and Paul hopes to submit a small grant for seabird monitoring later in the year.

## **Grand Cayman Parrot Survey**

Field Officer Stuart Mailer and Paul assisted the Department of Environment and the United States Fish and Wildlife Service with the bi-annual distance sampling survey for Grand Cayman Parrots, carrying out fully one-half of the field work. The survey, which took place in July of 2011, is used for estimating and monitoring the size of the parrot population.

## **Sister Islands Rock Iguana Species Management Plan**

Following on from an initial stakeholders meeting, Paul attended a planning workshop for the Sister Islands Rock Iguanas held on Little Cayman in August of 2011. Workshop Participants assessed the threats to native iguanas on the Sister Islands and developed a comprehensive species management plan to address them in an attempt to halt the population's decline. Various responsibilities were delineated and assigned to participating agencies and institutions. The plan was reviewed and formalized in late September 2011.

As a result, Paul spent the latter half of January 2012 participating in the population survey for Sister Islands Rock Iguanas on Cayman Brac. The survey was successful and a total of 81 iguanas were tagged.



## Grant Application - The Threatened Cayman Brac Parrot: a Flagship for Conservation

In partnership with The Royal Society for the Protection of Birds, Paul applied for a grant from the Darwin Challenge Fund. The application was successful and the Trust was awarded 20,000GBP for a full season nesting survey of the Cayman Brac Parrots.

Field work began in April 2012 and will likely finish in September. A total of nine nests were recorded through the breeding season, and a supplementary survey will soon be completed which assesses the Parrot's favoured habitat against properties across the entire island.

Representatives from the Royal Society for the Protection of Birds visited to provide feedback on the survey and to witness firsthand the difficulties presented by traversing the Bluff in the course of performing fieldwork.

While on the Brac Paul received sincere local support and concerted interest from many residents. Special thanks to Wallace and Edna Platts, Bonnie Scott, Jane and Glen Robertson and Chris Randall for providing accommodation and transportation. Thanks to all the volunteers and Trust staff who have assisted in this challenging task under extremely rugged conditions.

The work currently being done is the first step in safeguarding the Cayman Brac Parrot and establishing the bird as a conservation flagship species for Cayman Brac, much as the Blue Iguana is for Grand Cayman. The final report will be due in December 2012, and will pave the way to applying for further support from the Darwin Initiative. This application will likely be submitted in 2014.

## Field Officer Report

### Environmental issues

Stuart made an interesting discovery this year, identifying and publicising a butterfly featured in the Caymanian Compass “Photo of the week” which proved to be a Checkered Swallowtail, an invasive species and a potential threat to agriculture. Stuart also recorded a Clay-colored Sparrow in Grand Cayman, a new species record for the Cayman Islands, Atala Hairstreak butterflies on Little Cayman, a new record for that island, and a Ruff on Cayman Brac, a new species record for the Cayman Islands.

In addition, he identified a Cicada Killer Wasp photographed by a member of the public. Stuart tracked down specimens of this wasp in the British Natural History Museum collected by the 1938 Cayman Oxford Expedition, but which were only recently identified. Stuart also took part in the Grand Cayman parrot survey and parrot nesting fieldwork on Cayman Brac.

### Educational Projects

A highlight was hosting an expedition for winners of a National Geographic Hands-on Explorer Challenge on the Mastic Trail. Among other activities, Stuart gave a presentation of Cayman Endemic Birds at Savannah Primary School, and conducted a tree identification field trip for First Baptist School students. He also gave a presentation and field trip on endemic and native birds for Bodden Town Primary School students, and gave an introduction to the Mastic Trail for new school teachers and their Department of Tourism hosts.

### Public relations

Stuart was also busy on a number of promotional projects, including assisting the Ritz Carlton, Grand Cayman’s Blue Tip Golf Course with obtaining Audubon certification, as well as taking part in the London Bird Fair to promote the Cayman Islands as birding destination.

He contributed to articles for the National Trust

quarterly newsletters and Key to Cayman magazine, as well as providing photos and text for the new What’s Hot advertisement and for the Mastic self-guided booklet. He also revised the Mastic Trail rack cards to promote it as an eco-adventure.

Stuart had the opportunity to host a number of private Mastic Trail visits, with guests including Governor Taylor, visiting naturalist/writer Stewart McPherson, and visiting wildlife photographer Will Burrard-Lucas.

### Site improvement

With an important role in ensuring the Trust sites are well maintained, safe and attractive, Stuart contributed to projects at the Mission House, Governor Gore bird sanctuary, and Heritage Beach. He assisted with the design, production and installation of a new interpretative sign at the southern Mastic trailhead.

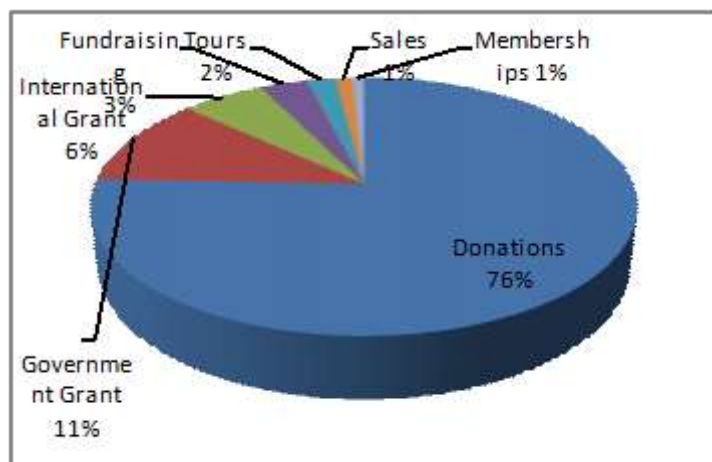

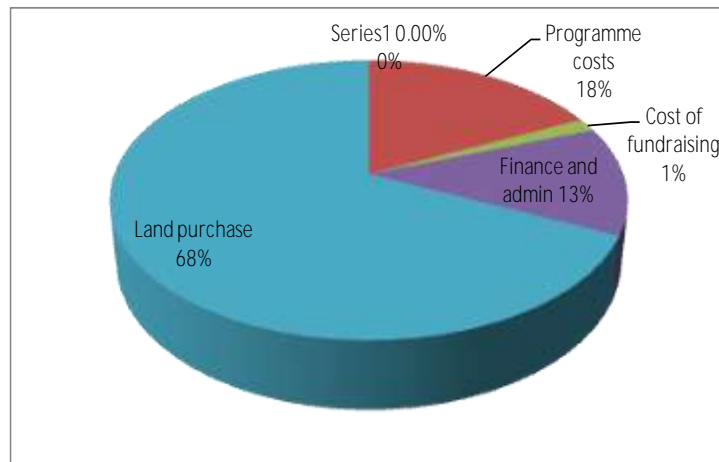

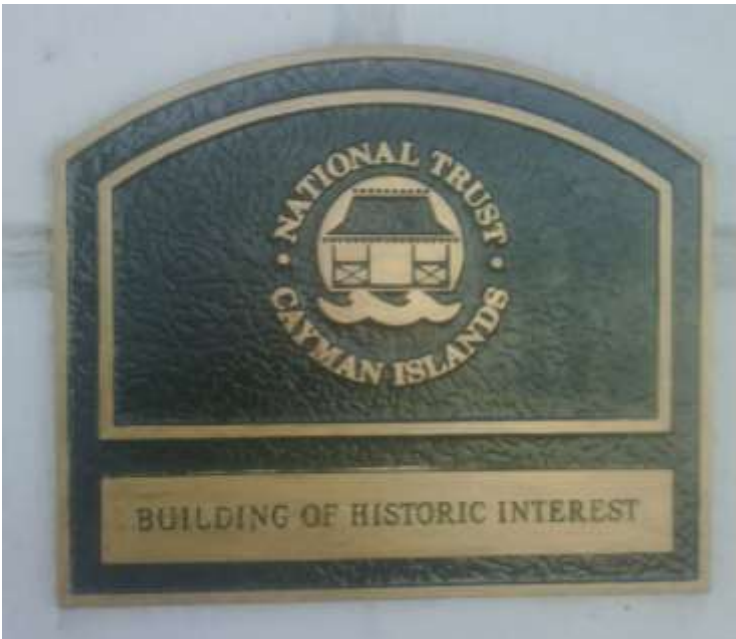

The Cayman Brac District Committee has 43 members of whom approximately one third are part-time residents. The Committee held eleven formal meetings during the year with an average attendance of 14. Six members from Cayman Brac attended the Trust AGM in September 2011.



A children's camp was held during the third week of July 2011 with 24 participants. This was organised by two members with volunteer assistance from persons in the community. The charge was kept to a minimum thus enabling children from a wide cross-section of the population to attend. Expenses were small as local businesses kindly donated snacks and transportation for field trips. Response from parents and children was very favourable, the only complaint being that the event should have lasted longer!

The Parrot Reserve Trail was thoroughly cleared by members during September and received minor attention to keep it easily passable throughout the year.

The Committee had actively been pursuing the acquisition of a parcel of wetland on the South side being the remnant of a larger property, the 'solid ground' portions of which were sold decades ago.

Unfortunately, after eventually tracing and contacting the American owners, it was determined that they were unwilling to part with what was left.

Members thereafter spent time exploring other, similar, land in the area, and identified two contiguous areas of swamp which appear to be worth considering for protection, either by acquisition or other means.

The Committee was pleased to welcome the Environmental Programmes Manager, Paul Watler, on his first visit to the Brac in November. After a tour of the Parrot Reserve, the adjacent 'Bight Road' and other places of interest Paul attended a Committee meeting and was able to share and discuss details of the overall operation and wider activities of the Trust.

The Iguana survey, conducted jointly by the Trust and Department of Environment throughout January 2012 was enthusiastically supported by Members, one of whom acted as overall coordinator. In addition to Trust members, twelve volunteers from overseas and a number from Cayman Brac, Grand Cayman and Little Cayman participated. The survey was supported by other members of the Committee who provided accommodation and transportation





also Moses Kirkconnell who provided lunch every day for the whole team. The results exceeded expectations with 81 iguanas being caught and tagged; unfortunately a small number of these have since been killed by motor vehicles, although a further 6, previously unseen, iguanas have been located and caught.

Following on from this success a Turtle nesting survey was commenced in May and is ongoing at the time of writing. In conjunction with the D.O.E., members and volunteers from the community patrol the beaches looking for nests. These are logged and observed until the hatchlings emerge. The educational value of this exercise has been exploited, with children being invited to witness emergences. As with the iguana survey, co-ordination has been by Trust member Bonnie Edwards.

The Committee operated a booth at the Brac Agriculture Show, selling books. This was very successful financially and good exposure for the Trust. Comments received from members of the public were noted and will be adopted for next year's show.

Members undertook foreshore cleanups on several occasions, sometimes in conjunction with another organisation. Although in some ways a futile exercise as more rubbish washes ashore daily, it is generally felt worthwhile to try and remove, in particular, items



which might be ingested by sea-creatures, such as plastic bags. The Committee was assisted in this by a group of 12 students from Eckerd College in Florida who volunteered to travel to the Brac at their own expense as part of the community service component of their courses.

The Committee

participated in the

Environmental Fair organised by the Lions Club of Cayman Brac and received an award for best booth. In preparation for this event a semi-permanent display depicting the work and activities of the Committee was compiled, which can readily be erected at short notice wherever it may be required in the future.

Our main fund-raising event, the Queen's Birthday Tea-Party, had a special significance this year in view of the Diamond Jubilee. Organised by a sub-committee of three members, who were unable to obtain co-operation from the weather, the event nevertheless proved a great success. Attendance was good, the silent auction successful and useful funds were accumulated.

Life member Moses Kirkconnell MLA acted as host and gave an inspiring speech about the

objectives of the Trust as a whole and how these translate into activities at District Committee level. Thanks to the Brac District Committee members for their enthusiastic support, and for the many other initiatives not mentioned here throughout the year.

# Cayman Sea Sense

Our seafood choices have a direct impact on the health of ocean habitat and species on a global and even local level. By choosing to eat sustainably harvested seafood it is possible for us to help preserve the diversity of fish that live and breed in our waters for future generations. Cayman Sea Sense (CSS) is a local seafood education program dedicated to helping restaurants and their customers make informed and environmentally positive seafood choices. The project assists local chefs and restaurant owners to reduce the number of non-sustainable seafood items on their menus. The use of a Cayman Sea Sense icon on a menu allows consumers to choose sustainable seafood options as certified by the Cayman Sea Sense Team.

## **Cayman Sea Sense primary goals include:**

- educating the general public about fisheries and aquaculture issues facing our oceans
- raising awareness about the impact that our seafood choices have on sustainable fisheries management practices.
- lessening the impact of the Cayman Islands restaurant industry on the world's fragile ocean resources as well as the health of our local coral reefs.

While many fisheries around the world are threatened with collapse, some fisheries remain healthy and sustainable because of successful management and responsible harvesting. Clearly some seafood dishes are better for the environment than others, but knowing how to tell the difference can be a real challenge for diners and restaurants alike. Cayman Sea Sense allows diners so



confidently identify and choose restaurants that provide environmentally responsible seafood menu items, and provides restaurants with the information and support to continuously improve menus from an environmental sustainability perspective.

## **Nassau Grouper**

The Nassau Grouper is a local example of how fishing pressure can devastate a species. These grouper once populated the coral reefs around the Cayman Islands in the thousands. Unfortunately, their populations have dramatically declined leaving these fish very vulnerable to extinction. Over half of their 150 known spawning sites throughout the Caribbean have been fished out of existence.

In 2003, realizing that this was probably the last chance to save local Nassau Grouper populations, the Cayman Islands government passed laws to protect this species from fishing during spawning season. This year the Department of the Environment extended the ban on fishing for Nassau grouper for another eight years. A healthy and growing Nassau Grouper population will not only seed the local reefs surrounding the Cayman Islands but could be at the epicenter for the recovery of the species everywhere in the



Caribbean.

### **The Lionfish challenge**

The recent invasion of lionfish has also put added pressure on our dwindling fish stocks. Although many of our local divers are attempting to teach snapper and grouper to eat lionfish, for the most part the local fish have not adapted to the presence of this invasive species leaving lionfish with no natural predators. It has been shown in the Bahamas that lionfish caused significant reduction in the recruitment of native fish by an average of 79% over a 5 week period. While it is clear that we will never remove the entire population, it is important to continue to cull the population in order to give local fish time to recruit and adapt. Lionfish are therefore the perfect choice to make when dining because every lionfish taken off the reef could mean the survival of thousands of local fish that are necessary for a healthy local reef ecosystem.

### **Sea Sense Initiatives**

This past year CSS has been busy on a number of initiatives. Every year we publish a seafood guide with the aid of the Department of the Environment and the Monterey Bay Aquarium. This guide outlines which species are the best to choose and which should be avoided in order to help people make informed decisions about their seafood choices. These guides are so popular that this year we printed twice the number as in the past as we've found it difficult to keep up with demand.

The Cayman Islands Tourism Association (CITA) kindly committed to paying for the printing costs at Cathy Church's Photo Centre. As our stickers have also proven to be very popular, the Department of Tourism generously helped us cover the costs of printing these in order to help us promote the organization.

Our Facebook page proved a worthwhile addition as well, enabling us to let our followers

know the latest news about both local and global fisheries issues. We also used our Facebook page to help launch Guy Harvey's films about the Nassau Grouper and shark populations which proved to be hugely popular and educational, as well as being instrumental in helping to obtain continued protection for the Nassau Grouper.

### **Partnerships in the Community**

We've welcomed new restaurants into our program including Kaibo Beach Bar and Karoo at Camana Bay and continue to reach out to more. It's been a successful year for CSS and we look forward to achieving even more in the future. This year the CSS team will once again collaborate with dive operators to promote local restaurants that have been endorsed by CSS.

Divers see first-hand the destruction of the reefs and the loss of biodiversity that are caused by unsustainable fishing practices and lionfish population pressures.

By asking dive operators to recommend Sea Sense restaurants, we can help both tourists and local divers make the best seafood choices.

Perhaps just as importantly, we help to support local businesses that have made the conscious and often difficult decision to serve only sustainably harvested seafood. With the continued growth of Cayman, it becomes critical that we make informed decisions to help protect the stability of species living in the fragile ecosystems surrounding our beautiful islands.



# Blue Iguana Recovery Programme

In another successful year for the Blue Iguana Recovery Programme, the restored wild population of Grand Cayman Blue Iguanas was boosted to 675 by the end of 2011, with stock in the captive breeding facility poised to step this up to

almost 750 by the end of the 2012 calendar year. This brings the programme within ca.3 years of reaching its long-term goal of 1,000 Blue Iguanas in the wild.

Captive breeding and rearing Blue Iguanas for release continues to be carried out to a high standard by the Programme's two Wardens, John Marotta and Alberto Estevanovich. In June 2012 the Wildlife Conservation Society's Dr. Paul Calle led a specialist veterinary team in health screening all the iguanas slated for release, and a sample of the breeders being retained in captivity. This valuable relationship with WCS has been ongoing now for a decade. The St Matthews Veterinary School kindly provide the laboratory space each year for processing and examining the necessary samples.

A purchase by the Trust of a small but key parcel of land for the Salina Reserve has expanded the area available for iguana releases. This was achieved with funding from our EU-EDF9 project "Management of Protected Areas to Support Sustainable Economies" (MPASSE) and funding from Maples Finance. The rough and narrow Salina access trail system was then extended into this area, in preparation for the 2012 releases.

The MPASSE project also underpins management of the Colliers Wilderness Reserve, where work is ongoing to develop a sustainable income stream for the programme and the protected area. Phase 1 of this work has been defined, and plans are being developed for planning submissions with assistance from the Department of Environment, Sandy Urquart, Mike Cowdery and CGMJ architects Robert Johnston and Will Steward. As part of the MPASSE project management we hosted an EU monitoring mission, and participated in quarterly

meetings of the international Project Steering Committee, including hosting the June 2012 meeting in Grand Cayman.

Led by its volunteer Director, Fred Burton, the programme recently added one new paid staff member in addition to the two Wardens. This is a Field Officer position, which was filled in June 2012 by a previous long-term volunteer, Doug Bell. The rest of the programme's ongoing staffing needs is met by volunteers and partnerships.

Locally, work at the captive facility has been boosted by regular help from Graham Seary, Jane Håkonsson, Christina Durango, Su Mander, Clare Dunning, Ollie Dubock and Blanca Bolea. Jane Cowdery has taken on the naming and sponsorship programme for individual Blue Iguanas, and Sarah Burton has been coordinating the international volunteer programme. Eleven international volunteers came to work with the programme during the year, for periods ranging from weeks to months, providing a substantial resource for fieldwork. We were able to house these international volunteers in Bodden Town, thanks to the ongoing generosity of Mary and Roger Bumgarner.

The BIRP's success continues to attract attention both locally and internationally. The BIRP Director was invited to speak about the programme at meetings in Sydney, Australia and Tennessee, USA, while then-volunteer Doug Bell spoke at a Wildlife Expo in London, in association with the CI Department of Tourism. On Grand Cayman the





programme's booth at the Pirate's Week district days was one of the most popular, especially thanks to efforts from volunteer Sue Bell.

Local support is also steadily manifested in corporate funding. Walkers, and Greenlight Re both continued their annual financial sponsorship, and Island Heritage selected the BIRP as one of their three featured organizations for their first "Charity Drive" fundraiser.

Other donations of note included a large pickup truck donated by PC Cast, which will prove especially useful when infrastructure work starts in Colliers Wilderness Reserve. Program funding also comes in part from our Blue Iguana Safari tours in the QE II Botanic Park, led by the BIRP Wardens. These tours are growing in popularity and significantly offset our recurrent staff costs.

### **Sister Islands Rock Iguanas**

In August 2011 the extensive knowledge and experience amassed over years working to restore the Grand Cayman Blue Iguana, was called on to help



address mounting concerns for the Sister Islands Rock Iguana, a near relative that is unique to Cayman Brac and Little Cayman. Evidence is mounting that the rate adult iguanas are being killed on the roads and by free roaming dogs on the Sister Isles is far beyond what the population can sustain. It appears the Sister Isles iguanas are plunging towards a risk of extinction much faster than is generally recognized.

The Trust and the Cayman Islands Department of Environment held a three-day workshop on Little Cayman, to formulate a three-year plan to deflect the imminent disaster and seek a stable future for these iguanas throughout Little Cayman, and in managed areas on Cayman Brac. The workshop was facilitated by BIRP Director Fred Burton, and attended by



stakeholders from all walks of life on all three of the Cayman Islands. John and Sandy Binns from the International Reptile Conservation Foundation (Arizona, USA) also participated. Janet Walker provided meeting space and accommodation at Casa Cassiopeia, Pirates Point provided additional accommodation, and Debbie Truchan kept spirits up over the long working sessions with splendid meals.

The meeting successfully resulted in a plan, [http://www.doe.ky/nbap/?page\\_id=461](http://www.doe.ky/nbap/?page_id=461) and an agreement to place the overall management of this work under the umbrella of the Department of Environment. The Trust will continue to play a key role within this framework.
