Olson Anderson, Nominee for Chairman

Dan Peterson, General Elected Member Nominee



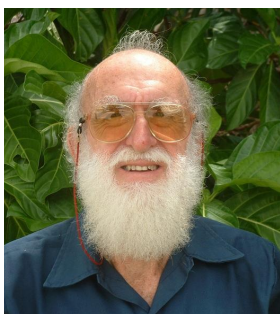
