Alice Mae Coe (Vice Chairperson)

Alice Mae's dedication to the National Trust began when she became a life member during the Trust's first meeting in West Bay, Grand Cayman. This meeting aimed to promote the creation of the NTCI under the National Trust for the Cayman Islands Law 1987 (Law 22 of 1987), now known as the National Trust Law (2010 Revision). The NTCI's mandated purposes resonated with Alice Mae, who grew up in a family that respected nature's beauty and bounty, particularly in the mangrove-protected haven of the North Sound. Her family's frequent outings on the catboat to fish or explore the grounds along the rocks reinforced the significance of environmental conservation in her life. Moreover, her 45+ years of employment with a prominent local law firm instilled in her a deep regard for the importance of following laws for the good of society and its people. Alice Mae's interests span a wide range of community-focused activities, but what unites them is her unwavering commitment to standing up for what is right, even in the face of adversity. For her, doing what is right is more important than personal gain or self-interest. Alice Mae has served on Trust council in various capacities, most recently as Vice Chair on Executive Council and as West Bay District Committee Chair for more than 30 years.



Brad Wammes (Treasurer)

Brad Wammes is a Chartered Professional Accountant with over 15 years of senior financial leadership across healthcare, advertising, and entertainment sectors. As Chief Financial Officer at OceanMed, he leads the financial strategy for one of the Cayman Islands' premier healthcare institutions, focusing on operational efficiency, long-term sustainability, and fiscal integrity. His career includes senior roles with global organisations such as Publicis and Spin Master, where he developed a strong track record in financial planning, risk management, process automation, and stakeholder engagement. Brad's leadership has consistently delivered improved financial performance, strengthened internal controls, and supported strategic growth. As National Trust Treasurer nominee, Brad hopes to bring not only deep financial expertise but also a personal passion for environmental conservation and cultural heritage. He has authored a number of books including Threatened Plants of the Cayman Islands – the Red List as well as The Little Blue Book. Fred currently holds the post of Manager of the Terrestrial Unit at the Department of the Environment. He formerly worked as the Environmental Programmes Manager of the National Trust and was a key player in establishing the Cayman Islands' terrestrial protected area systems and worked on wildlife conservation habitats. In 2007 Fred was awarded an MBE for his services in conservation of endangered species. Most recently he has served on the National Trust Council, Environmental Advisory Committee and the Blue Iguana Conservation Steering Committee.

Craig Caffarelli (General Council)

Craig and his family moved to Grand Cayman from Chicago five years ago. While living on island, Craig has been an active volunteer for the National Trust at Blue Iguana Conservation, considering its conservation work essential to maintaining the biodiversity of the Cayman Islands. He also supports several other local charities. Utilizing his business background and finance and accounting skills, he is a mentor to two small local businesses. In the US, he sits on the boards of a national literacy charity and an affordable housing charity in Chicago. In 1994, Craig helped create GEM Realty Capital, a Chicago-based real estate investment firm specializing in private and public market opportunities, as Chief Operating Officer and Chief Financial Officer. Craig currently serves on the 2024/25 Council as National Trust General Elected Member as well as an active member of the Fundraising Committee.



Katie Ebanks (General Council)

Katie originally moved to the Cayman Islands for a career opportunity on Little Cayman in 2016 but remained here for the last ten years after falling in love with the country and her husband. She has had the pleasure of living on each of the Cayman Islands, while working with a variety of organizations (CCMI, DoE, and Brac Scuba Shack). While Katie is a marine scientist by training, her professional passions have shifted to focus more on educating and inspiring others to be better environmental stewards. She is also a strong believer in taking action, so she has enjoyed volunteering with various local efforts such as the DoE's Turtle Beach Monitoring Programme, Plastic Free Cayman, Meals on Wheels, the Humane Society, and the Eco-Divers Reef Foundation. Katie is currently a member of the Cayman Brac District Committee of the NTCI, where she organizes monthly beach cleanups (26 consecutive cleanups and counting), co-hosts monthly Trivia Nights to benefit the Habitat Fund, and acted as Secretary for the 2024/25 year. She feels the mission and values of the NTCI parallel her own and is excited for the potential opportunity to give back in an even greater capacity as a nominee for General Council.

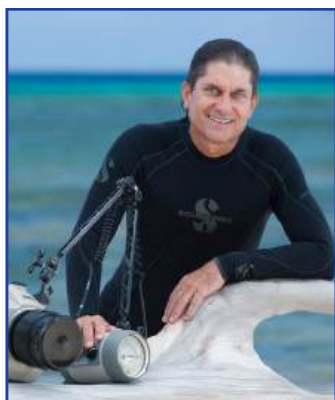
Richard Harrison (General Council)

He has also consulted on TCFD (Task Force for Climate Related Financial Disclosures) and community involvement has included being a voted council member on the Chamber of Commerce. Brigitte Kirkconnell-Shaughness (General Council)

Upon completion of her BA in Business Administration at Loyla University in New Orleans, Brigitte worked for a family-owned and operated Home Centre/ Building Materials store in Pennsylvania. Since 1992, Brigitte has worked primarily as the Managing Director of Kirk Home Centre and is a member of the boards of directors for various other companies. Over the years she has had the privilege of serving on various private sector and statutory authority boards such as the Civil Aviation Authority, the CI Chamber of Commerce, the Business Staffing Plan Board, the National Security Council and the Judicial & Legal Services Commission. She is a former member of the Meals on Wheels board of directors and in the 1990's she was a council member of the National Trust. Brigitte believes that our islands natural beauty and heritage must be protected while balanced with sensible development in order to improve the quality of life for Caymanians and residents. Her father, the late Capt. Charles Kirkconnell was one of the members of the Legislative Assembly who voted in favour of the National Trust for the Cayman Islands Bill in 1997 in order to protect Caymanian heritage. Brigitte currently serves as General Elected Member of the National Trust Council for 2024/25.



Courtney Platt (General Council)

Courtney is a Caymanian commercial photographer, diver, and environmental advocate whose life has been shaped by the sea. After studying marine biology for three years, he graduated from Cal Poly, SLO in 1983 with a BSc in Physical Education due to limited job prospects in his original field. His passion for marine life began at age 8 and led to over 5,000 scuba dives in Cayman, including deep submersible missions to 1,000 feet and mixed gas dives to 350 feet. Since 1976, he's been capturing underwater beauty, shooting eight assignments for National Geographic and building a prestigious local clientele. Witnessing the decline of reef ecosystems, Courtney launched the Reef Fish Restoration Initiative, urging residents to avoid eating reef fish and to use the marine parks app to support conservation. His 2015 TEDx talk at UCCI proposed a Caymanian-only fishing permit, now under government review. Beyond the ocean, he's documented Hurricane Ivan's destruction in *Paradise Interrupted*, helped develop Crystal Caves ecologically, and contributed wildlife photography to the National Trust. Courtney's work blends science, art, and activism— and as a National Trust Lifetime Member he is eager to help preserve Cayman's natural heritage for future generations.

Diana Quin (General Council)

Diana is a Lifetime Member of the National Trust who arrived in Cayman in 1985 with her late husband Charles Quin (who previously served on the NT Council as Legal Advisor). She initially worked as a physiotherapist before becoming a full time mother to three sons. In 2004, she opened her own business selling handmade Oriental Rugs , in which she spent 17 years before retiring. She has previously volunteered with the PIN programme through St Georges Church and is a member of the Garden Club of Grand Cayman. She is very keen to work to help save the natural environment of Cayman, with an especial interest in local birds. When not chasing after grandchildren she loves to garden , grow vines, nurture Whistling Ducks on her natural pond and 'dabble' in watercolours. Diana currently serves as on the Trust's Public Relations Committee and as General Council Member for 2024/25.



Lisa Scott (General Council)

Lisa was born and raised in George Town, Grand Cayman. She has a deep-rooted passion for preserving the culture and heritage of the Cayman Islands. After a successful career in banking, culminating as Vice President, she retired to raise her family as she continued to serve her community. Her efforts include revitalizing the George Town Clock Tower and organizing the scoring and recording of the national song Beloved Isles Cayman and compiling the poetry and music of her Great-Grandmother and National Hero, Leila Ross-Shier. She continues to support community engagements, local arts, and historical education through events, publications and public talks. Lisa's hope is to bring a heartfelt commitment to honor Cayman's legacy and foster community pride to the Trust as a council member for 2025/26.



Candy Whicker (General Council)

Candy was raised in London and worked as an investment banker there until moving to Cayman in 1989.
